Meeting called to order at 7:00 by Ashley Longbow.

Approval of past minutes: May minutes approved

Baron/Baroness Report (Shannon and Regina): Hi! We had May Crown in the barony. For the most part it went smoothly; lots of compliments. Hoping the site will work well in the future. Port-a-potty bill has been forwarded to Madrone. A chair bid from Lord Dalbock (description and discussion later, picture passed around.) Went to Grand Thing in Stromgard. They have a new baron and baroness now. We went to ren fair in Ellensburg last week. Awarded a baroness favor to Sir Duncan; our champion from Ambergard. Always looking for awards! Sargentry trials in Wastekeep coming up in August. As far as I know we only have one person from our barony participating.

OFFICERS' REPORTS

Seneschal (Ashley): (Pat attended the seneschal meeting at May Crown in lieu of Ashley, as she had prior engagements. Pat reported: family events are changing.) Documents about the changes for family activities were received in my e-mail May 25th. The system for background checks is working again. There's an admin retreat September 27th-29th in the Barony of Glymm Mere, \$80 per person, for seneschal and exchequers. (Pat moves to cover the cost should they wish to go, motion passed. Can a deputy go in place?) It does not mention anything other than current officers; I will look into who else can attend. Message from SCA kingdom seneschal: If youths overnight are involved and a site requires a clause for our insurance to cover molestation and sexual abuse, our insurance will not cover it. Do we have any guilds in the barony officially to send in reports? No. Kingdom events deputy sent out an email announcing the need for bids on May Crown, July Coronation, and September Crown 2014. (Reggie: May Crown in Sportsman Park?)

Exchequer(Fiona): We have \$6587.44 in the bank, and no outstanding checks. Waiting for payment from Madrone. I'm trying to close books out, need port-a-potty bills sent on. (bills were forwarded as seen in baron and baroness report.)

Chamberlain(Regina): Everything stowed away from May Crown. (Pat: What's the condition of the dragonwing? Good! We need other things more!)

Rurik will contact Sarah, she should do one next year, to let her know that we are interested in doing a demo here next year.

Are there any other ren fairs? Greenwood, not interested in SCA. Wenatchee, too far. Ellensburg is the closest one...
