Our lands stretch from Ellensburg/Cle Elum in the north to Grandview in the south, Tappico in the west to Moxee and beyond in the east. We are located approximately 145 miles southeast of Seattle, Washington; 200 miles southwest of Spokane, Washington; and 185 miles northeast of Portland, Oregon.

Born in year of Mount St. Helens' fiery eruption, 1980, the City of Yakima, is an area of rich volcanic soil. It is said that Yakima County ranks first in the United States in the number of all fruit trees and that it produces more apples, mint, winter pears, and hops than any other county.

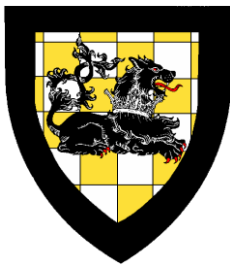
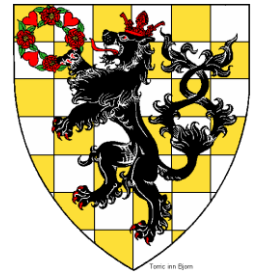
