Vulcanfeldt Business Meeting Minutes Monday, October 13, 2025

Attendance: Alric Ivarsson, Chiara Sarta, Ionamyst, Kata Byfluga, Lhianna The Madde, Lowell Kinney, Rurik Gjafvaldsson, Steinnar Hrafensfuri, Tai Tjorkillsdatr, Thorsten Kvendulfson. Quorum met according to Minor Carta guidelines.*

Meeting called to order at 7:03 PM by Rurik Gjafvaldsson, Seneschal.

Approval of September meeting minutes: Motion made by Iona, 2nd by Chiara. Motion unanimously approved.

Baron and Baroness (Steinnar & Tai): Steinnar and Tai attended Vulcanalia and Baron's Ball. At Vulcanalia awards were given in court, report was sent to Dexter Gauntlet (*Order of Precedence*). New Champions are Uhtred (Heavy), Thorvald (Rapier) and Evrard (Archery). We had a newcomer Angel who came on Friday and returned to enjoy the Friday night fun by the firepits.

Their Excellencies announced that they are now accepting petitions to participate in Sergeantry trials.

At Baron's Ball Vulcanfeldt's champion Uthred won the tournament. Tai attended Oktoberfeast in Wealdsmere.

Seneschal (Rurik): 3rd quarter report is complete. Please send in quarterly reports by the end of the month and copy the seneschal and their excellencies.

Sergeantry - Sergeants meeting at Vulcanalia. Discussed several aspects of sergeantry going forward. Sergeants will be holding a small meeting for the hour before the council meeting every month to discuss improvements to the sergeantry process in Vulcanfeldt as well as helping any candidates that need assistance in their studies.

Chronicler (Ashley): Absent. Rurik Gjafvaldsson taking notes. Report: Meeting minutes posted and the 3rd quarter report submitted to Kingdom Chronicler.

Webminster (Shannon): Absent. Lhiannan is now the deputy with plans to assume the office in December when Shannon moves out of the area.

Exchequer (Chiara): Monies from Vulcanalia have been deposited back into the checking account. NMR report for Vulcanalia and NMR check has been sent. Storage was paid. *(Banking details are not published in the minutes. If you wish to know bank statement amounts please contact the Seneschal and Exchequer).*

Chamberlain (OPEN): Shannon O'Duncan has both trailers stored on his property. We have been asked to store the Kingdom's old list boards locally as a contingency in case the new boards (in Aquaterra) cannot make it over the mountains for a Kingdom event on the east side of the Kingdom.

Herald (Cem): Absent - reported NTR.

Master of Stables (Steinnar): Held a practice this week at Larson Park but it got dark quickly.

Winter indoor sites - Steinnar, Daegar, and Rurik are trying to meet with Ron Anderson at the Selah Civic Center to talk about possibly renting the SCC for winter practices indoors. Rurik has talked to Gretchen at the City of Grandview regarding dates for regional practices once a month at the Grandview Community Center Gym. The two dates for the remainder of the year are November 15 and December 14 from 10 am to 2 pm. The total cost is \$500 (\$150 per day plus a \$200 deposit). Motion made to approve the rental of the Grandview community center by Tai, 2nd by Ionamyst - Motion unanimously approved.

Rapier (Cem): Absent - reported NTR

Archery (Alric): Archery practices are scheduled for October 15 and 29. The time will be moving to 5 pm due to losing daylight. There is talk about scheduling a date to conduct some archery range maintenance at Colonial, TBA.

*Baroness' War, April 3-5, 2026 (Event Steward: TBD) - Grandview site is not available. Other possibilities include the Ag Museum or Basin City Park where Baron's Ball was held. Hammar is inquiring regarding the date availability for Basin City Park. There is no charge for the park, but they do accept donations. Thorsten volunteered to co-steward if someone else were willing to mentor him on stewarding.

*Sergeants Trials, June 19-21, 2026 - The three (3) Inland baronies found that this is the only date that works for all three baronies and does not have any conflicting events in the Kingdom. Site would be Basin City Park. The intention would be to permanently host at the same site, with the host rotating between the three baronies.

*Vulcanalia, October 9-11, 2026 - There were many in the Inlands that did not attend this year. Many in Wastekeep were attending Banner War and a lot of the archers from Wealdsmere were attending a large archery event in Artemesia. Several people are going to reach out and see what the overall feel is for moving the event back to the October dates.

Chamberlain

Seneschals are the legal representative for the branch. They are responsible for the coordination of the Society activities in their branch.

Exchequers are responsible for the handling of all SCA funds within their branch.

Heralds provide heraldic services to their branches including consultations, field heraldry, town cries, and court heraldry.

Marshals are responsible for making sure that all SCA combat and similar athletic activities are conducted in a manner that is safe and enjoyable for both the participants and the spectators.

Arts and Sciences officers are the local resource for arts & sciences in the branch. They may arrange classes, workshops, promote competitions, and hold monthly gatherings.

Chroniclers act as the secretary for the branch, attending monthly meetings, publishing meeting minutes and monthly newsletters.

Chamberlain ensures that the baronial items stored in the trailer and the storage unit are available when needed for events.

Lists manage contestant scores for heavy and rapier tournaments. Currently we host tournaments at Vulcanalia and Baroness War.

Landed Barons and Baronesses

A landed Baron and/or landed Baroness are the Crown's representative within a Barony and provide the inspirational leadership for a barony. They are empowered to hold courts, grant awards which are recognized in the Kingdom's Order of Precedence; and can have Sergeants, Yeomen, Gallants, Courtiers, and Lancers. Landed Barons and Baronesses are required to report to the Crown and their Royal Highnesses one month prior to each Coronation.
